Mare Owner and Stallion Owner agree as follows:

- 1) Mare Owner will purchase one fresh semen breeding from the Stallion Owner for the ("Stallion") Rocazino (Oldenburg DE 433330696606). The cost is \$600 USD. Payment will be made to Equito Dressage, LLC via check or credit card.
- 2) The \$600 USD fee is due at least seventy-two hours before any semen will be shipped. Mare Owner understands that no semen will be shipped until all fees have been paid to both the Stallion Owner and the Collection Facility.
- 3) If the breeding was won via a stallion service auction, only handling, collection related, and shipping fees will be due to the Collection Facility. No fees will be due to the Stallion Owner. All other terms will still apply.
- 4) All sales are final upon acceptance of this Agreement. There will be no refunds given for an unused breeding purchase. This breeding may not be sold without the express permission of the Stallion Owner.
- 5) Fresh semen sperm count, motility, collection and packaging procedures meet and/or exceed normal industry standards.
- 6) Mare Owner is responsible for all collection related, shipping, tank rental, and handling fees associated with delivery of the semen from the Collection Facility. Any shipments made to Canada may incur additional fees for paperwork, CFIA shipping permit request, and USDA endorsement fees.
- 7) Semen will be collected at the below location ("Collection Facility"):

Please contact the Collection Facility for current shipping fees, protocols, and requirements. All fees related to shipping and transfer of the semen will be due to the Collection Facility prior to shipment.

- 8) Stallion Owner shall provide one dose of fresh semen as stated above from the Stallion, but provides no other guarantees as to the condition of the semen once the semen has left the Collection Facility. Stallion Owner shall not be responsible for lost semen shipments or delays in delivery not within the control of the Stallion Owner, such as missed flights, weather delays, failure of third party service, or acts of God.
- 9) Stallion Owner guarantees that Stallion is Equine Viral Arteritis ("EVA") negative as of January 2017 and that Stallion is vaccinated annually against EVA.
- 10) Stallion Owner recommends that a licensed veterinarian handle the insemination of the semen into the Mare.
- 11) If semen is used for a mare other than the Mare named in this Agreement without approval from Stallion Owner, another \$600 USD fee and completed contract will be due immediately.
- 12) Mare Owner assumes all responsibility for the condition and management of the Mare and will bear all risk of loss or damage to the mare whether by death, disease, injury, infection or otherwise; Mare Owner therefore agrees to indemnify and hold Stallion Owner, or any person employed or associated with Stallion Owner, harmless for all damages associated therewith.
- 13) Mare Owner is responsible for keeping Stallion Owner informed regarding approaching ovulation to make sure there is enough time to collect and ship semen without missing the ovulation. Should

Mare Owner not provide at least twenty-four hours-notice for a collection, Stallion Owner will do her best to accommodate the Mare Owner, but no guarantees can be made.

- 14) Stallion Owner provides no live foal guarantee and no guarantee of a pregnancy under this Agreement.
- 15) Should no pregnancy be obtained with the dose of fresh semen, Mare Owner may pay Stallion Owner an additional fee of \$1000 USD to obtain a live foal guarantee fresh semen contract, which entitles the Mare Owner to continue fresh semen breeding attempts on the Mare. At that time, this Agreement will become null and void and a live foal guarantee fresh semen contract will be sent to the Mare Owner.
- 16) Stallion is approved for breeding with Oldenburg North America/International Sporthorse Registry, American Hanoverian Society, German Oldenburg Verband, American Rhineland Studbook, and American Warmblood Registry. The ability for a foal to be registered with each studbook will depend upon the Mare. Contact the registries above for further registration information.
- 17) Mare Owner is responsible for compliance with registry requirements for the use of fresh semen and payment of any fees for the subsequent registration of any foals conceived. Stallion Owner will provide a breeding certificate to the Mare Owner.
- 18) Upon confirmation of pregnancy at approximately fourteen days and confirmation of a heartbeat at approximately thirty days, Mare Owner will inform Stallion Owner so that a breeding certificate can be issued.
- 19) In the event of Stallion death or the inability to produce and ship viable semen from the stallion contracted for this service, Stallion Owner will substitute this fresh semen agreement for either frozen semen from the same Stallion or fresh semen from another Equito Dressage, LLC owned stallion of Mare Owner's choice.
- 20) This Agreement constitutes the entire agreement between Stallion Owner and Mare Owner.
- 21) This Agreement shall be interpreted in accordance with the laws in the State of North Carolina, and its validity and administration shall be governed by said laws.

Endorsement of this Agreement by both parties represents a binding contract, subject to all the above terms and conditions.
